6. Entry and insurance

Registrations can be made on the on-line page of the Off-road Department: https://www.chronomoto.hu/offroad

Drivers younger than 16 years are allowed to participate in the event according to the national rules, but these drivers will not classified in the FIA CEZ Championship.

In case the entrant's intention to start is prevented, he/she must notify the organiser immediately in written form, as soon as the problem occurs until the start of the administrative checking at the latest.

Failure to do so may result in fine of 25 000 HUF imposed by the OFRB.

The entry fee should be paid to the account of Nyirád Racing Center Nonprofit Kft at Erste Bank. In both cases, please, write the driver(s)' name(s) in the Message field.

The maximum number of participants is 140. Reaching this number, the entrant will be put on a waiting list. The COC and the Organiser decide on the acceptance of the entry, taking into account the received category entries.

The entry fee for competitors from abroad is 300 Euros in CEZ categories and 195 Euros in National categories.

The above listed amounts include the entry fee, the insurance and the paddock usage right. The listed fees are gross amounts.

Entrance permission

The organiser provides service tickets for 5 persons of each competitor (driver + 4 persons) and a paddock ticket (car ticket), which can be received at the scene (the Paddock gate) on arrival. There is a further opportunity to purchase a 2-day ticket only by prior arrangement for a discount 10.000 HUF / 25€.

Parking in the paddock area with passenger car is prohibited! The team parking will be on Sümegi road already on Friday! Entry is still possible from Tapolca, from the ticket offices. Parking will be assisted by security guards.

Timing:

There is transponder timing during the race. Every driver is obliged to use a transponder. Those drivers who do not have their own transponder can hire one for the race for $5\,000$ HUF / $13\,\epsilon$ at the administration checking.

Insurance

Every driver has to be insured by a Driver's insurance. As part of the entry, the driver has to take out liability insurance in case of damage for a third person. The insurance is in effect from the start and expires at the end of the race or at the moment of an elimination or exclusion of the race.

The entry fee includes the insurance fee!

7. Prize giving ceremony

It is according to the FIA CEZ and the Hungarian National Off-Road Regulations. The prize-giving ceremony will take place in the Pre-grid area.

8. Reservation of rights and the responsibility of the starters

The organiser reserves the right to change the current Regulation until the beginning of the race with the following conditions: in case of a change, the drivers are informed with a Bulletin including a date and an order number, which is approved by the department in advance, from the start of the race this right applies to the Stewards. By signing the registration form, the drivers subject themselves to the regulations of the Regulation of the Event and the Bulletins. Participating the race is the risk of the drivers. By signing the registration sheet, the drivers state, they have no claims for damages towards the organizer resp. they waive a claim for damages.

9. Environment protection regulations

Each driver has to have an at least 4x5 m plastic foil at the place provided for the team, where repair work is done on the car in order to avoid pollution caused by any leakage and a 150 litre plastic bin liner to collect rubbish/waste. They can be checked at any time during the competition. Possible deficiencies can be punished by the Stewards!

Charging electric cars in the paddock area is strictly prohibited!

10. Safety regulations

Each driver has to have a minimum 5 kg loaded fire extinguisher in working order at their own paddock area. They can be checked at any time during the competition. Possible deficiencies can be punished by the Stewards!

11. Checkings

On Saturday (06. 09. 2025) there will be an opportunity for administrative checkings and scrutineering for the CEZ categories, but only with prior permission from the Clerk of the Course!!!

Administrative checks

Only the competitor must attend the administrative check, which will take place at the administrative office. Administrative checking is only for **VALID** technical passport holder!

Scrutineering -

Every participating racing-car has to turn up at the technical checking. (Scrutineering Area) The Start permission can be withdrawn from every car that turns up after the end of the technical checking.

Drivers under the age of 18 must show up in racing clothes at scrutineering! We would like to draw the attention of all drivers in the CEZ category to the fact that the CEZ 2025 technical rules apply to them!

Tyre warmer or any kinds of device that keep either dry or wet tyres warm are forbidden.

12. The event

Practice: A maximum of 10 cars can be on the track at the same time during practices. Each driver has to complete at least one timed lap during the practices. In case of failing this term, the Stewards make a decision about the Start permission of the driver. The races will be organised with a Joker lap.

The distance of the races:

Warm up: 2 laps
Official practice: 4 laps
Heat races: 5 laps
Semi-final and final races: 5 laps

13. Parc Fermé, results – Protests

Parc Fermé

After the final races of the event, those cars that have been flagged down in the final race or those drivers excluded from the final with their cars have to drive directly to the official Parc Fermé and the cars stay there at least 30 minutes after the publication of the results. The Stewards decide about the end of prohibition. In this zone it is strictly forbidden to carry out any kind of repair work on the car, refilling is not permitted, either.

Protests, appeals

The right to protest is reserved to the competitor. Protests shall be lodged in accordance with the relevant points of the FIA International Sporting Code and the MNASZ General Sporting Rules and Regulations. If the protest is unfounded, the protest fee or part of it may be withheld.

Protest fee: 300 000,- HUF

In the event of a technical protest requiring a disassembly, the stewards shall on the basis of a proposal from the technical steward may impose a deposit in addition to the protest fee. If the protest is unfounded, the costs of dismantling will also be charged to the protestor.

The competitor has the right of review and appeal against certain decisions of the Stewards in accordance with the relevant Articles of the FIA International Sporting Code and the MNASZ General Sporting Rules and Regulations within the applicable time limits. Fee for appeal: 200 000 HUF
